**EXTRACT OF MINUTES OF 04<sup>TH</sup> OF 2023-24 MEETING OF BOARD OF DIRECTORS OF DDEV PLASTIKS INDUSTRIES LIMITED HELD AT 2B, PRETORIA STREET, KOLKATA – 700071 ON MONDAY 11<sup>TH</sup> SEPTEMBER, 2023 AT 5:30 P.M.**

**To consider and approve the request received from Mrs. Anita Devi Surana for re-classification from ‘Promoter Group Category’ to ‘Public Category’**

The Board was informed that, Mrs. Anita Devi Surana who was holding 3855 equity shares in Ddev Plastiks Industries Limited by virtue of transmission of shares from Late Surendra Kumar Surana, Promoter of the Company and subsequent bonus issue made by the company and who had subsequently disposed off (sold) the same, had vide her letter dated 09.09.2023 requested the Company for re-classification of her shareholding from ‘Promoter & Promoter Group Category’ to ‘Public Category’. The Board was also informed about the rationale for such re-classification that the outgoing promoter is in no way related to any of the business carried out by the Company. Further she is not engaged in the management or day to day affairs of the Company and also does not have any right either to appoint any Director of the Company or an ability to control the management or policy decisions of the Company in any manner whatsoever including by virtue of her shareholding and that none of her act would influence the decision taken by the Company.

Further the Board was also briefed that Mrs. Anita Devi Surana had specifically mentioned in her stated request letter that she and her daughters (descendants) seeking reclassification are satisfying all the conditions specified in sub clause (i) to (vii) of clause (b) of sub regulation 3 of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (‘the Listing Regulations’) and also confirmed that at all times from the date of such re-classification she and her descendants seeking re-classification shall continue to comply with conditions mentioned in sub-clauses (i), (ii) and (iii) of Clause (b) of sub regulation 3 of Regulation 31A and shall also comply with conditions mentioned at subclause (iv) and (v) of clause (b) of Sub- regulation (3) of Regulation 31A of the Listing Regulations for a period of not less than three years from the date of such reclassification, failing which she/they shall automatically be reclassified as promoter/promoter group, as applicable.

Accordingly, on the basis of the rationale and the confirmation provided by her in accordance with provisions of Regulation 31A of the Listing Regulations, the Board was of the view that the above-mentioned request for reclassification of Mrs. Anita Devi Surana from ‘Promoter Group Category’ to ‘Public Category’ be accepted and approved by the Board of Directors of the Company, which shall be subject to the approval of BSE Limited and/or such other approval, if any, as may be necessary in this regard.



It was also discussed that Proviso (a) to Regulation 31A(3)(a)(iii), provides for an exemption with respect to seeking approval from the Members in the General Meeting for reclassification from 'Promoter Group Category' to 'Public Category' where the promoter(s) seeking reclassification and persons related to the promoter(s) seeking reclassification, together, do not hold more than one per cent of the total voting rights in the listed entity.

Therefore, in view of the above, as Mrs. Anita Devi Surana along with all other persons related to her (i.e., immediate relative) do not hold more than one per cent of the total voting rights in Ddev Plastiks Industries Limited, the condition to seek approval of the members in the General Meeting, as laid down in Regulation 31A (3)(a)(iii), can be dispensed with.

The Board considered the matter and passed the following resolution unanimously: -

**“RESOLVED THAT** pursuant to the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with its Amendments thereto ('SEBI Listing Regulations'), and subject to the approval of BSE Limited and/or such other approval, if any, as may be required, the consent of the Board of Directors be and is hereby accorded to approve the reclassification of holding(s) from 'Promoter category' to 'Public category', for the following shareholder and her descendants, being her three marriage daughters:
